# **Definitions and Interpretation**

  - **c.** A reference to a person includes firms, companies, government entities, trusts and partnerships;
  - **d.** "including" is understood to mean "including without limitation";
  - e. Reference to any statutory provision includes any modification or amendment of it;
  - f. The headings and sub-headings do not form part of this Privacy Policy

## Scope of this Privacy Policy

- **3.** This Privacy Policy applies only to the actions of Storage Land Limited T/A Storage Land and Users with respect to this Website. It does not extend to any Websites that can be accessed from this Website including, but not limited to, any links we may provide to Social Media Websites.

#### **Data Collected**

### How we collect Data

- **6.** We collect Data in the following ways:

## Data that is given to us by you

- **7.** Storage Land Limited T/A Storage Land will collect your Data in a number of ways, for example:
  - **a.** When you contact us through the Website, by telephone, by post, email or through other means;
  - **b.** When you use our services, in each case, in accordance with this Privacy Policy.

# Data that is collected Automatically

- **8.** To the extent that you access the Website, we will collect your Data automatically, for example:
  - **a.** We automatically collect some information about your visit to the Website. This information helps us to make improvements to the Website content and navigation, and includes your IP address, the date, times and frequency with which you accessed the Website and the way you use and interact with its content.

#### Our Use of Data

# **Keeping Data Secure**

### **Data Retention**

- **15.** Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this Privacy Policy or until you request that the Data be deleted.
- **16.** Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

### **Your Rights**

- **17.** You have the following rights in relation to your Data:
  - a. Right to Access: the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify; update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive". Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why;
  - **b. Right to Correct:** the right to have your Data rectified if it is inaccurate or incomplete.
  - **c. Right to Erase:** the right to request that we delete or remove your Data from our systems.
  - **d. Right to restrict our use of your Data:** the right to "block" us from using your Data or limit the way in which we can use it.
  - e. Right to Data portability: the right to request that we move, copy or transfer your Data.
  - **f. Right to Object:** the right to object to our use of your Data, including where we use it for our legitimate interests.
